

## CLIFFORD MODERN LIVING LISTS ON HKEX MAIN BOARD TODAY

### CLOSES AT HK\$0.62 PER SHARE ABOUT 35% ABOVE OFFER PRICE

(Hong Kong, 8 November 2016) – Trading of shares of **Clifford Modern Living Holdings Limited** ("**Clifford Modern Living**", together with its subsidiaries, collectively the "**Group**"; stock code: 3686), a renowned diversified service provider of diversified services including property management, retail, catering and ancillary living services in Guangdong Province, started today on the Main Board of HKEX.

The shares were actively traded and recorded a satisfactory price performance, peaking at HK\$0.63 per share, and closed at HK\$0.62 per share, representing an increase of around 37% and 35% respectively compared to the offer price of HK\$0.46 per share. A total of approximately 299 million shares were traded with turnover amounting to approximately HK\$161 million.

**Ms. Man Lai Hung, Chairman and Executive Director of Clifford Modern Living**, said, "The listing of Clifford Modern Living in Hong Kong today has given it access to an international financial platform, thereby markedly enhancing its corporate image and opening a new chapter of development. The Group will elevate its positioning in the property management industry and continue to consolidate its diverse services, as well as keep exploring new opportunities to expand its income sources and boost profitability. It will also strive to realize synergies among its different business segments, ultimately aiming to generate more lucrative returns for shareholders."
